We as a District donated \$534 from 5 donations during July 2021. Thank you Sidney Lions, PCC Ben Apeland, DG Mike Tobin, PDG John Mathis, PCC Dan Krum. Some of these are monthly donations and others are not, but they all add up.

There are 10 months left in Campaign 100, and we are at 73.9% to our goal of \$300 million. Fires continue to force evacuations around Montana, the United States and Worldwide. A category 4 Hurricane is headed toward Louisiana and the Southwest, Flooding in Tennessee destroyed one town. An Earthquake has hit Haiti before repairs for the last one has been completed. Human suffering around the World requires us as Lions to do our part if our motto "WE SERVE" means anything. But, that is not all we are supporting- we also do many projects to make lives more secure and accessible experiences to disadvantaged.

Montana District 37 – Cabinet Meeting, July 17, 2021; Bozeman, MT; Meeting face to face and via "Zoom"

- I. Call to Order by DG Michael Tobin at 12:00 Noon
  - a. DG Tobin led the cabinet in the Pledge of Allegiance
  - b. PDG Lary Garrison provided an invocation
  - c. Roll Call Sign in documentation
  - d. Introductions by those in attendance
  - e. DG opening comments Excitement regarding the new Lions year. The #1 priority will be communications with special emphasis on the communications between clubs and the district and LCI; work continues on a new website that will allow easy access to virtually all district activities, LCI information and will include information submitted by any Montana Lions club; every Montana Lions club will be asked to increase club membership by plus one (1) member; their will be an emphasis on training all key club leaders within the State.
- II. Minutes April 25, 2021 cabinet meeting; motion VDG Scott Dornfeld, second by PCC Dan Krum, to approve the minutes. Passed.
- III. Financial Reports PCC Dan Krum provided the reports. Motion PCC Dan Krum, second by PCC Ben Apeland to approve the reports. Passed.
- IV. Additions to the agenda
  - a. Purchase equipment
  - b. Website update
  - c. PCC Ben Apeland, ID campaign
- V. General Business
  - a. Grants, LCIF, PDG Lary Garrison Laurel, their park project is moving ahead, bidding is in process, work should start in May and be finished in October; Denton grant is pending; diabetes camp grant (\$40,000.00) has

been approved and funds have been received. There are many grant options available to clubs, contact PDG Lary Garrison for more information.

- b. Administrator's Report PDG Dennis Kopitzke presented the report; information only, no action required
- d. Club Health Assessment The district is down in membership; many clubs are still not meeting; the Charlo club has folded; the Lolo club has folded as has the Lewistown club.
- e. Zone Reports None
- f. Club Visitations Visitations have not started; plans are being developed for 2021-2022 visitations.
- g. Committee Reports

GMT – Lion Steve Melby will be the GMT leader; DG Michael Tobin and Lion Steve have met and established expectations.

GLT – Team leader is IPDG Mike Tobin. The Leadership Retreat will be held in Polson on October 8-9. Invitations have been extended to 47 Lions with a commitment date of July 31. IPDG Mike Collins is preparing a training manual, with input from other Lions; training will be provided for VDG's as well as for club officers. Plans continue to be developed.

GST – Lion Jesse Gonzalez, nothing new to report

LCIF – PDG Lary Garrison will continue to serve as the district's chairperson. A pledge form associated with Campaign 100 was given to all meeting attendees.

NAMA – North American Membership Alliance; GMA, Global Membership Approach; efforts will continue to be involved in the membership efforts.

#### VI.Old Business

- a. Magnetic Signs The signs have arrived and efforts are being made to distribute 4 signs to every club.
- b. Virtual Diabetes Club DG Mike Collins continues to work on establishing a state wide virtual diabetes club.
- VII. New Business
  - a. Communications/Website DGE Mike Tobin will lead the effort to update the district website and develop a district communication plan. Efforts will be made to contract with a business that can develop and manage the district's website. The contractor needs to have experience working with non-profits.

Six proposals were received with EDGE from Helena selected as the contractor that will work with the district. Approximate cost \$8750.00 or \$920.00 annual fee; \$75.00 per month. 50% of the cost must be paid "up front". Motion by PCC Dan Krum, second by PID Dave Hajny to approve the financial arrangement. Passed.

EDGE will train several Lions regarding the website. The district will continue to have input on design features. A district website administrator will be chosen.

- b. Administrator's Contract DG, VDG's and IPDG will review the agreement and make recommendations for changes. DG Michael Tobin has authority to sign an agreement on behalf of the district. Motion by PID Dave Hajny, second by PDG Lary Garrison to approve the proposal. Passed.
- c. Treasurer's Contract No contract needed; compensation approved via district budget
- d. Endorsed Projects Annual reports may be submitted in writing or made verbally at the first cabinet meeting of the new Lions year. Approved via unanimous consent.
- e. Policy Update Cabinet members reviewed the proposed changes/updates. Proposed change, Article 6, Section A: All appointees must be in good standing of clubs within the District. Motion by CDG Scott Dornfeld, second by PCC Dan Krum to approve the change. Passed.
- f. Lewistown club, designated funds There is \$3807.38 being held by the district associated with the Lewistown club. Motion by PDG Lary Garrison, second by VDG Scott Dornfeld that the funds be held by the district and be available for the possible growth of a new Lewistown Lions Club. Passed.
- g. 2021-2022 Training Training will happen in 2021-2022.
  - i. Leadership Retreat will be held on October 8-9 in Polson; final plans for the event are moving ahead.
  - ii. Governor Training Ongoing training will be provided to the district governor and vice district governors. Plans continue to develop aspects of the training
  - iii. Region/Zone Chair Training DG Tobin, VDG's Dornfeld and Gertiser, IPDG and other key Lions will be used to help train region and zone chairs as well as club officers
- h. Administrator's Financial Report Information only
- i. 2021-2022 Directory Same format as in the past several years; copies of the directory will be provided to every club president and secretary, cabinet

members and others with a need for a directory. Approximately 170 copies will be printed and distributed prior to Labor Day.

- j. 2021-2022 Cabinet Almost all positions have been filled. There is still a need for a Zone Chair for zone 13.
- VIII. Additional Items
  - a. District Equipment DG Mike Tobin is making plans to secure equipment (computer, flash drives, passwords, email addresses, mailing addresses, other related) to provide transferable equipment and information from current DG to incoming DG thus maintaining continuity in the leadership needs of the district.
  - b. Website Issue addressed earlier in the meeting.
  - c. PCC Ben Apeland, ID campaign PCC Ben continues to be a candidate for International Director. He is collecting information from LCI on the details associated with his candidacy. Quarterly reports will be provided to the cabinet.

Note: IPDG Mike Collins provided a farewell message to 2020-2021 cabinet members and wished new administration, cabinet and Montana Lions the very best in the 2021-2022 Lions year.
