# District LCIF Co-Chair

#### **August 2024**

From August 15th to the 18th PDG Mike Tobin and I will be in San Antonio, Texas for CA1 LCIF Strategy Sessions. We will arrive Thursday afternoon and return Sunday morning.

What are the benefits to District 37? There are several that will make a difference for both us and District 37. First, Mike and I will meet with the LCIF staff, some of them new, that we need to work with in getting and closing grants. Secondly, Mike and I will learn of changes in grants, their benefits and requirements. Thirdly, Mike and I will meet other LCIF Coordinators from across the United States and learn what many of them are doing with applying for grants and doing for fundraisers.

There is no need for these sessions without the LCIF structure. There are no grants for Childhood Cancer, Diabetes, Disaster Relief, Disaster Preparedness, Disaster Recovery, Major Disasters, District and Community Impact, Hunger, Leo Service, Lions Quest, Matching, and Sight/First Grants without the financial support of Lions around the world. 34% of District 37 Lions Clubs and 4.5% of individual Lions in District 37 made a contribution to LCIF during the 2023-24 Lionistic year. If you or your club did not contribute last year please give serious consideration of contributing this year.

No donation is too large-and no donation is too small. District 37 contributed \$34,408.09 last year. The nine cents came from a donation box at the convention in Havre. I am sure someone put the change from their pocket into the box.

  - d) District Governor Opening Remarks –DG Raleigh discussed Mission 1.5. His big push this year will be Club Branches where only 5 members are required.
- 2. Minutes: Motion by Steve D, second by Mike T to approve the April 21, 2024 minutes as distributed. Motion passed unanimously.
- 3. Financial Report: Steve reviewed the financial reports ending June 30, 2024, noting that the District is in a decent financial position with over \$200,000. He noted that we were about \$2,000 over in the budget for 2023-24 (website was also over by that amount). He recommended that we review the current year budget to ensure that we have a balanced budget as currently the bottom line is a \$-24,000. Mike T. recommended that the governor's team review the budget. Richard noted that we need a GAT (action team) line item in the budget.

Steve moved to adopt the resolution 2024-01 for banking. Ben asked if the funds are staying in Stockman or moving. Steve will be moving the funds in Stockman to 1<sup>st</sup> Bank of Montana which has a local branch in Choteau. Mike C seconded the motion and it passed unanimously. Dave H recommended that since we have a new treasurer, that Raleigh and Peggy work with Steve to develop good processes to ensure that payments are all valid and correctly paid. Motion by Mike C, second by Dave F to approve the financial report. Motion passed unanimously.

- 4. Additions to the agenda are noted in Item 8 below. Raleigh commented that he hasn't completed the district committees.
- 5. Old Business
  - a. LCIF outstanding grants Mike T. requested the cabinet's approval to close out the Plus Optix Grant. Steve moved to approve the closing of the Plus Optix grant. Mike C. seconded the motion noting that he would like to see a summary when we are voting on grants. Motion passed unanimously. Mike T also reported that Glendive is submitting two grants - a matching grant to upgrade the Pool's bathrooms to be ADA compliant and one for hunger (not matching) for new appliances for the food bank. Mike T reported that the LCIF district giving is 25% higher than the prior year.
  - b. Club Health Assessment May Report –Brian noted that to date we are positive.

- c. Club Officer Training Mike C. reported that we have not yet redone the videos but Peggy had Edge provide links to three of the Lion Portal "how to" videos under the Training tab for club secretaries. We will have training at the Convention in Helena. Mike C. has applied for attending the Faculty Development Institute (FDI) in Chicago. He hasn't been accepted as yet, but if he is invited to go, he'd ask for reimbursement for the registration and travel. Peggy was asked about the secretaries who have not updated the officers for the current year. She reported that she emailed approximately half the clubs who hadn't reported in the system as of June and we are now down to eight clubs that have not started the process. Mike C. also reported on the Leadership Retreat to be held in September in Choteau.
- d. Addition to the Policies 3<sup>rd</sup> Vice District Governor Raleigh reviewed the proposed Article 2 Section A1 to add a 3<sup>rd</sup> VDG to the District (see attached). Discussion followed regarding budgets. Richard moved to approve bringing on a 3<sup>rd</sup> VDG program as a pilot program adding \$1500 from reserves to fund the position. Motion was seconded by Mike T. Motion passed unanimously. Steve moved to add Article 2, Section A1 to the policy manual. Seconded by Dave F and motion passed unanimously.
- e. Review/Update to Policy Article 7 Endorsed Projects Proposed changes were reviewed (see attached). Richard moved to accept the amendments to the endorsed projects and was seconded by Steve. Motion passed unanimously.
- f. Updates to District 37 Facebook Page Jessica sent out a request and Steve was the only one that responded. Brian recommended that a "help wanted" for assistance be in the August Newsletter. Steve also has some ideas for how to find others to assist Jessica.

#### 6. New Business

- a. 2024 Convention Report Brian reported that we haven't received a final report from Havre.
- b. 2025 District Convention Dan reported that the 2025 Convention will be May 2-3, 2025 at the Delta (Colonial Inn) in Helena. Dan confirmed that there is \$3,000 of seed money available from the District. Ben agreed to assist and reported that ID Anthony Paradiso from New York (a sitting judge) has been selected and notified. Dan has both Helena clubs and Townsend club onboard to assist with the convention.
- c. Montana Glasses Raleigh noted that there's a question of whether this is a district project or not. It was confirmed that several Walmarts have quit taking the glasses and John is no longer going to be a collection point. Ben noted that when you collect 300 pairs of glasses, the club should put that on their club service report. Peggy will link the post that tells how the clubs can forward the glasses directly to Seattle to the Donate Page. Corrina offered that if any clubs aren't willing to forward the glasses to Seattle, Ennis will offer to collect the glasses. Peggy moved to make Collecting Glasses as a District Project. Steve seconded the motion and it passed unanimously.
- d. Website security proposed changes to directory Peggy reviewed the options that Edge has provided in providing more security for the Directory page the first option was discussed over a year ago have a login/password that would be provided to current members but that option didn't seem to provide much security band because it would be difficult to disseminate the login information to the appropriate folks. The other option is to have a "registration process for anyone who wants access to that information. The registration would go into a "que" and be reviewed and either approved or rejected. Once registration is approved, that member would be able to access the directory. This upgrade would cost \$500 as Edge would have to set up additional parameters to make it work. A third option is for everyone to use the Lion Portal and just have a listing of our current officers with no contact info. Richard moved to approve the \$500 to Edge to create a registration for members. Steve recommended a fourth option that we could just remove the email information off of our website as they can be accessed through the Lion Portal by every member. Peggy noted that Deanna said that could be done without

taking the emails out of the database. Richard retracted his motion. Steve moved to remove all emails from the website and have "contact forms" for all of the district team members as needed and Mike C seconded the motion. Motion carried with Dave H abstaining.

#### 7. Officer Reports

- a. DG/VDGs Club Visitations Raleigh reported that they have not started visitations as 3<sup>rd</sup> VDG had not been finalized. He noted that Gary Bissell will be put into the 3<sup>rd</sup> VDG position.
- b. Administrator's Report Peggy reported that since the convention, she has been working with several secretaries on the new Lion Portal. Five of the clubs on her initial list had in fact entered their officers, but the portal report did not include them (even though 23-24 had all 59 clubs). She has emailed technical support but hasn't received a response. The website directory has been updated with 2024-2025 officers for all clubs that updated their officers in the new Lion Portal. The website directory has also been updated to reflect all current district officers. She will be providing Edge with the new lists for International officers and directors along with updating the "our organization" section as soon as she has Jon's bio and photo and LCI has updated the 1<sup>st</sup> year International Directors. Peggy updated her contract to reflect the duties that have evolved with the development of the website. Mike T added that if the governor's team will request that the club secretaries that update any information LCI also pass that information on to the district secretary.

#### c. Zone/Region Reports

Margaret – Zone 3 – Reported that most of the clubs are on vacation. Columbia Falls just completed a celebration for Don Lawrence. They also do summer concerts in the park and are getting ready for Heritage Days where they will have a float in the parade. Sunrisers sponsor "Firecracker Baseball" where they make \$2-3,000. Adrian in Eureka is still working on a playground that they've been installing and she has encouraged him to officially complete the paperwork for a Leo's club. Working on details for all of the zone clubs to have a booth at the fair.

Raleigh introduced Zone 13 Chair, Hondo from Ennis and Zone 8 Chair, Bob from Choteau. Bob reported that Choteau completed their parade and they sponsored a concert at the new band shell. Their trip of the month will kick off in August. Sunburst is setting up a 501C3 utilizing the EZForm.

#### 8. Committee Reports

- a. GMT Richard reported that he has done Bozeman Gallatin Empire, set a date for Missoula Southside and is setting a date for Butte Mile-Hi. July 17<sup>th</sup> he will be at the new club members induction for Joliet. He has also been working with George Chenowith in Livingston.
- b. GET Brian is working with George Chenowith in Livingston to get a club branch going there and Brian is working on their Tri-Fold. Havre is working on Chester and Raleigh asked Brian to work with Zone 8 Chair, Scott. Brian is also hoping to work with White Sulphur Springs in the Shields Valley area. Bozeman Heritage Christian School is interested in a Leo Club. Adrian has agreed to be the Leo Chair.
- c. GLT See above Leadership Retreat is in Choteau September 20-21. Will hopefully do zoom training for the portal and will do training at the convention.
- d. GST Dennis reviewed his report (see attached). Dave H. requested that Dennis provide his reports so he can submit them to the Global Service Team officers.
- e. LCIF Mike T reported that this is his and Lary's last year but he told Corinna that he would be willing to do another tour. Corinna asked if they coordinate visits with governor's visits. Mike said it's good to do just an LCIF visit and not interfere with the governor's visit.
- f. Plus-Optix no report for the summer.

- g. IPID Ben reported that the USA/Canada Lions Leadership Forums can be related to all areas of your life not just Lions. Ben asked for the following schedule be put on the website:
